# **Financial Report**

Bill Meck, Treasurer/CFO, reported that financials are shown through the month of February. Tuition and Fees Revenues are down \$1,629,374. The decrease in Coast Flight for the first 3-terms is \$492,000. After adjusting Coast Flight, we are down \$1,137,000. Comparing two line items, Resident and Non-Resident tuition, we are down \$1,158,000 and down a little over 7,000 credits for the same 3-terms as a year-ago. Local, State, and Federal Support are trending where they should be. Other Income is trending a little higher. Expenditures: Salaries and Fringes are down \$807,499. Services line is up \$223,000 after adjusting for Coast Flight. Materials and Supplies are down \$123,467. Other Current Expenses are up \$99,351. This results in a net decrease in our total expenditures of \$608,000 over last year. Restricted Funds 2: Revenues and Levy Expenditures are comparable to a year ago.

#### **IACCT Report**

Richard J. Gaumer reported that the Phi Theta Kappa All Iowa Academic Banquet was held on February 28, 2018 t. Three of our students were honored and it was a very nice evening.

March 6, 2018 was the Day on the Hill. All community colleges had representatives present. Dr. Sprouse spoke to all of our Legislators.

The Revenue Estimating Conference came in \$300,000 higher for FY18. Future Ready Iowa is close to an agreement, with substantial changes in the original legislation, which are more favorable to community colleges. Everyone

(all education and training organizations) should be held to the same academic approval standards that community colleges are held to. There should be better standards for training and qualified people must do the training. Talks are continuing with the Legislators about community colleges having more flexibility in raising our own property tax.

Rich traveled to Kirkwood Community College on Thursday, March 8, 2018. Kirkwood is looking to cut \$3.25 million dollars from their budget. Rich will travel to Creston on Tuesday, March 13, 2018 and this will be his last college visit. He has visited all 15-community colleges.

The 2018 IACCT Conference will be held in Mason City July 18-20, 2018 and the 2018 ACCT Leadership Congress is taking place at the New York Marriott Marquis, Wednesday, October 24–27, 2018. Connie Hornbeck, Chair, Association of Community College Trustee will be in attendance.

# Resolution Authorizing Redemption of Outstanding Bonds and Directing Notice be Given

Ashley Moyer, Executive Director, Continuing Education & Workforce Solutions reported that "with this resolution we are asking for your permission to officially call the Series 1010-1 bond that financed a 260E project for Musco Lighting in Oskaloosa, Iowa. The amount was for \$550,000 and they planned for 50 new jobs, and hired 50 people. Sufficient funding will be on hand to fully pay off this bond by June 1, 2018."
