### MINUTES OF THE BOARD OF TRUSTEES

January 13, 2020

The regular Board of Trustees meeting for Indian Hills Community College was held on January 13, 2020, in the Board Room on the Main Campus, Indian Hills Community College, Ottumwa, Iowa. Board President Mr. John Pothoven called the meeting to order at 4:02 p.m.

# Approval of Agenda

It was moved by Mr. Gaumer and seconded by Ms. Nichols to approve the board agenda. The motion carried.

## **Approval of Monthly Claims**

Board member Ms. Danowsky reviewed the list of bills on behalf of the board and reported that all questions were answered by appropriate staff members.

#### Motion

It was moved by Ms. Danowsky and seconded by Mr. Keck to approve the bills list for the month of December 2019. The motion carried.

### **Financial Report**

Mr. Michael Lee, Treasurer/CFO, reported Revenue minus Expenses trending behind last year, down about \$171,000. Total Revenue is lower by \$293,125. Tuition and Fees Revenues are lower \$692,818 and \$200,000 is due to course fees associated with Coast Flight. Local Support is up \$48,000 due to property taxes. State Support is up \$200,000. Other Income line is up\$126,471 due to reclassification. Expenditures: Salaries and Fringes are down \$60,083 from one year ago. Services are lower by \$265,032. Materials and Supplies are higher at \$180,460 and Other Current Expenses are up \$13,849. Restricted Funds 2 is tracking slightly ahead of last year and Expenses are in line with expectations.

## Motion

It was moved by Mr. Keck and seconded by Mr. Kirkpatrick to approve the Financial Report. The motion carried.

## **IACCT Report**

Mr. Gaumer reported the ACCT Board had not yet met in January. Each person received a handout about the Trustee Leadership Webinar on Wednesday, January 15, 2020. This is a special webinar for new Community College Trustees. Mr. Gaumer also reported on an announcement that the Governor is going to be offering her State of the State Address on Tuesday, January 14, 2019 at 10:00 a.m. This can be streamed. Community colleges need legislators to continue to support our Job Training funds and facilities. One in ten Iowans are affected by community colleges. Mr. Gaumer drew attention to the chart showing Regents Institutions receive \$10,770 per student, Private Colleges receive \$4,589 per student and community colleges receive \$2,501 per student. The Last Dollar Scholarship is a good program. It allows students who might not been able to go to college receive financial help and enroll. The ACCT Board met with the new Speaker of the House, the House Minority Leader, and the Senate Minority Leader. The Presidents met with the Senate Majority Leader and if there is anything that they are unanimous about, it is, they are not going to allow community colleges to raise property taxes. > Mr. Michael Lee, Treasurer/CFO, reported that IHCC is moving forward with the renovation of the Main Campus Dining Hall. This project will remodel and reequip the serving area and kitchen. The project is being designed by OPN Architects and IHCC will use Story Construction as Construction Managers. The project will be bid in phases. Equipment will be bid this month and traditional pieces will be bid in February and brought to the board for approval. A targeted budget has been placed at 4 million dollars and the date for completion is the opening of fall term or August 31, 2020.
