

Indian Hills Community College Coronavirus Aid, Relief, and Economic Security (CARES) Act Higher Education Economic Relief Fund (HEERF)

The information below outlines the Indian Hills Community College rationale, decisions, and processes for distribution of the CARES HEERF funds to provide students with emergency financial aid grants for expenses related to the disruption of campus operations due to COVID-19.

- In response to the COVID-19 pandemic, Indian Hills Community College (IHCC) chose to move face-to-face classes to an alternative method of delivery thus, disrupting a large number of students attending IHCC. Beginning March 18, 2020 classes were moved to an online format and to instructional delivery over Zoom. Instructors were charged with finding internet resources and simulations for instruction. Students needed to access course sessions and materials remotely through technology. Residence life and food service areas were closed, also disrupting students and their learning.
- With the proclamation of the CARES Act, IHCC determined that we would take a multi-faceted approach in awarding our funding. Our first process would be to provide a portion of the CARES funding as quickly as possible to a large group of students. We also determined that we would like to reserve a portion of monies in order to provide additional funding, via an application process, to students with greater or continued need.
- We asked our Information Technology staff to provide us with a listing of students that were enrolled in our 20/Spring term. On April 13th we received our first listing of students who were enrolled. This listing contained 1653 names and was our first step in determining the population of eligible students that might be receiving CARES funding.
- On April 17, based on additional guidance from United States Department of Education, IHCC removed students that did not meet the eligibility criteria listed in the HEERF document question 9 and under HEA Section 484. The College determined that the number of enrolled credits would be our starting point for providing funding to students impacted by campus disruptions.
- IHCC was eligible for \$1,099,829 CARES Act funding and our intent was to award approximately \$750,000 of those funds to students based on their number of enrolled credits for the 20/Spring term. Our revised listing returned 1182 students being eligible to receive funding. Those 1182 students had 11,473 credits among them. We were able to award students \$65 for every credit enrolled for the 20/Spring term for a total of \$745,745 for the first push to students.
- Checks were created on April 29, and mailed to students on April 30, 2020. Included with those checks was a flyer (Appendix A) detailing from where the funds came (CARES Act), how the amount each student received was determined and how the funds should be used (in accordance with the federal CARES and HEERF guidelines).
- All students who were or could be eligible for the Indian Hills CARES funding received an email (Appendix B) on Thursday, April 30, 2020. Also on April 30, 2020, information regarding the Indian Hills CARES funds was posted to the Indian Hills COVID-19 webpage at www.indianhills.edu/COVID, and an Indian Hills CARES press release (Appendix C) was sent to all newspapers in the Indian Hills 10-county region.
- The student email, the COVID-19 webpage (Appendix D), and the flyer mailed with the Indian Hills CARES checks included information about the Indian Hills CARES application (Appendix E). The Indian Hills CARES application allows students to request additional monies related to the disruption of college operations due to COVID-19. The Indian Hills CARES application opened to students on May 6, 2020.

Indian Hills Community College has received \$1.1 million in federal funding through the Coronavirus Aid, Relief, and Economic Security (CARES) Act to address the financial need that students face because of disruption in college operations due to COVID-19.

- Students enrolled in credit courses in the spring term and who are eligible for federal financial aid will receive a check from Indian Hills CARES. The amount of this check will be based on \$65 per credit hour for the number of credits in which the student was enrolled as of March 13, 2020.
- These checks will be mailed on April 30, 2020 to each eligible student's permanent address.
- Students should use the Indian Hills CARES funds to cover expenses related to
 the disruption of campus operations due to Coronavirus. Eligible expenses include
 food, housing, course materials, technology, healthcare, transportation, and
 childcare.
- Students who believe they may be eligible but who have not completed a FAFSA
 (Free Application for Federal Student Aid), should complete the <u>2019-20 FAFSA</u>
 (Indian Hills School Code: 008298) as soon as possible. Eligible students will be contacted by the Financial Aid department within three business days.
 - Students may receive help in filing the FAFSA by calling the Educational Opportunity Center at 641.683.5315 or emailing eoc@indianhills.edu.

Students who feel they have additional financial need caused by the disruption in college operations due to COVID will have the opportunity to apply for additional funds. The <u>Indian Hills CARES</u> application will be available starting May 6, 2020.

FOR IMMEDIATE RELEASE Indian Hills CARES Funds

Indian Hills Community College has received \$1.1 million in federal grant funds as part of the Coronavirus, Aid, Relief and Economic Security (CARES) Act Higher Education Economic Relief Fund (HEERF) to assist students with expenses caused by the disruption of college operations due to Coronavirus.

According to HEERF guidelines, these funds must be distributed to credit students who are eligible for federal financial aid and were not enrolled exclusively in an online program. The federal guidelines suggest that students should use Indian Hills CARES funds to cover expenses related to the disruption of campus operations due to Coronavirus. Eligible expenses include food, housing, course materials, technology, healthcare, transportation, and childcare.

Indian Hills President Dr. Marlene Sprouse noted, "Our students have done a great job of adapting to the alternative methods of delivery implemented due to Coronavirus. However, we know that these changes have resulted in additional personal expenses for many students. We hope that the Indian Hills CARES funds will help alleviate expenses in technology due to moving to online and virtual formats, housing or travel expenses due to the closure of residence halls or any expenses students may have as a result of Coronavirus."

Indian Hills will be disbursing the HEERF funds to eligible students in two ways. Beginning April 30, the college will disburse \$750,000 of the \$1.1 million funds to 1,182 eligible students. Eligible students will receive a check, sent to their permanent residence, based on \$65 per credit hour for the number of credits in which the student was enrolled as of March 13, 2020.

The remaining \$350,000 will be awarded to eligible students who have additional financial needs caused by the disruption of college operations due to Coronavirus. Students who are currently eligible for the Indian Hills CARES funds or who could be eligible after completing the Federal Application for Federal Student Aid (FAFSA) can apply for the additional funds using the Indian Hills CARES application at www.indianhills.edu/cares starting May 6, 2020.

Sprouse also noted, "We would love to be able to distribute Indian Hills CARES funds to all students, but we must follow the federal guidelines. We are trying to get as many students qualified as possible by encouraging all students who have not completed the FAFSA to do so. Students who have a need, but do not qualify for federal funds, may qualify for emergency funds through the college and the Indian Hills Foundation."




