# **Ways to Give**

**INDIAN HILLS FOUNDATION SCHOLARSHIPS** are awarded to full-time and part-time students attending Indian Hills Community College. To be eligible for an award, a student must be a graduate of an accredited high school or have earned an HSE. Scholarships are awarded to students who demonstrate one or a combination of the following: academic excellence, exceptional aptitude for a chosen area of study, outstanding personal qualities, or financial need. A student may receive only one Indian Hills Foundation Scholarship in an academic award year. Foundation scholarships are applied to tuition on the student's account at Indian Hills Community College.

**GENERAL FUND SCHOLARSHIPS** are academic awards that are applied to tuition on account at Indian Hills.

**DESIGNATED (NAMED) SCHOLARSHIPS** are awarded by the Foundation in the name of a business, industry, individual,\*memorial, trust, or other name as determined by the donor. A \$600 minimum contribution is required to establish an annual designated scholarship. (Please contact the Foundation office for details.) Sponsors of designated scholarships establish the criteria for eligibility and may specify that their recipient be from a given high school or service area or be enrolled in a specific area of study. Foundation Designated Scholarships may be applied to tuition and other costs on the student's account according to the wishes of the donor. At present, the Foundation administers over 200 designated scholarships. Many of them provide multiple awards.

**PERPETUAL (ENDOWED) SCHOLARSHIPS** are designated scholarships endowed with a one-time gift, a minimum amount of \$12,000. Only the interest is used for scholarships. The principal is placed in a restricted account to generate income. The Indian Hills Foundation receives gifts to provide scholarships to students of Indian Hills Community College. All donations are tax deductible under Section 170 of the Internal Revenue Service Code, to the extent allowable by law.

\*A memorial scholarship is a wonderful way to honor the memory of a loved one.

# **2016 Outstanding Service Award Recipients**



### Brenda Ragen - Retiree

Former IHCC employee Brenda Ragen, who worked at the college for more than 25 years, was given the Outstanding Retiree Award for her involvement and support of the college since retiring. Ragen is the vice president of the IHCC retirees' group, the Trailblazers. She has organized fundraisers for scholarships for deserving students, has assisted with the Foundation auction and organized the Trailblazers when they decided to prepare cookie and candy trays at Christmas for IHCC staff on the Ottumwa and Centerville campuses.



### Jean Dell - Lay Citizen

The Outstanding Lay Citizen Award went to Jean Dell, an active member of the Indian Hills Foundation Board for the past six years. This award honors an area community member who has made notable contributions to IHCC. Dell chairs the Planned Giving committee, serves on the Investment committee and is actively involved in the Foundation's special events and fundraisers. She assists each year with the scholarship auction and was a key figure in helping organize the Women Supporting Women event that has raised almost \$60,000 to fund scholarships for women attending Indian Hills. Dell and her husband, Bill, attend many IHCC events and are long-time supporters of the college.



### Bob Ford - Alumnus Award

Bob Ford, owner and COO of Socius Marketing, a search engine optimization marketing firm based in Tampa, Fla., was honored with the Outstanding Alumnus Award, which recognizes achievements since an alumnus graduated from Indian Hills. Ford, a 1970 IHCC graduate, has a long history of growing successful businesses. Currently, under his leadership, Socius has assisted over 700 companies' websites across 46 states and four countries. He was also instrumental in helping with the growth of AEGON, a Texas-based insurance company, and Midland National Life in South Dakota, and he owned and operated an E-Z-Go dealership. In his presentation it was noted that Ford has carried his lowa farming work ethic and principles throughout his career.



### Freddy Miranda- IHCC Employee Award

Freddy Miranda, the former Director of International Affairs at IHCC, grew the college's international enrollment from 35 to nearly 170 in a little over three years. Miranda spearheaded countless student-focused initiatives, and he was recognized for contributing in a variety of ways to the growth that was achieved. A native of Ecuador, Miranda was referred to as "a dedicated person.... who was known across campus because of his unique personality.....and was so well-known in the international education field, that people from across the United States and around the world were affected by his sudden passing." Miranda's award was presented posthumously, as he was tragically killed earlier in the year while on a recruiting trip in South America.



### Ray Ryon - IHCC Employee Award

Ray Ryon, IHCC Computer Software Development program educator, was honored due to his service, loyalty and support of the college. In addition to his teaching, Ryon, helps at numerous activities, including the annual Lego League robotics competition. One of his nominators said perhaps the most important facet of his dedication to Indian Hills is his service to students, saying his "knowledge of the field is evident. He continually educates himself and maintains current technical knowledge, sometimes even cutting-edge technology." Ryon is recognized as a skilled and patient instructor, who makes every effort to help students succeed.

# The Dr. Jim Lindenmayer Award for Exceptional Leadership

In 2013, the Dr. Jim Lindenmayer Award for Exceptional Leadership was created to recognize those who lead with compassion, integrity, service and vision. The first recipient was Dr. Jim Lindenmayer, who retired from Indian Hills in 2013 after a 33-year career. This year, Lori Schaefer-Weaton was selected as the recipient.

Lori Schaefer-Weaton, the President of Agri-Industrial Plastics in Fairfield, accepted the Jim Lindenmayer Leadership Award in recognition of her leading with compassion, service, integrity, and vision. Under her direction, the fast-growing company recently completed the largest expansion in its 38-year history, adding 104,000-square feet to its existing 240,000-square-foot facility. Since Schaefer-Weaton joined the company as Director of Business Development 12 years ago, their sales have more than doubled.
