Dr. Ahmed is board certified in Emergency Medicine and sub-specialty board certified in Emergency Medical Services by the American Board of Emergency Medicine.

He has more than 15 years' experience as a paramedic having worked 911, interfacility transports, critical care, and as both a tactical medic and flight medic before becoming an RN and ARNP. Session Descriptions

Keynote: "Life or Limb: Field Amputation to Rescue a Trapped Patient" - Dr. Azeemuddin Ahmed & Chuck Gipson

This session will review a trauma call resulting in a field amputation of a trapped patient. We will look at the decision-making process to implement and activate a field amputation team, review of a field amputation protocol and review of follow up care to the patient. (EMS-T, RN)

BLS Sessions:

Special Delivery: Post-Partum & Neonate Care in the First 30 minutes - Janet Taylor

We've all had to take the obligatory childbirth class but what happens after the delivery? What should we expect? What should mom and baby being doing? What if the placenta doesn't deliver when it should? What if the baby turns blue? What if mom was diabetic? All these questions will be answered and more. (EMS-O/Peds, RN, RT)

"Basically," Great Cardiac Care - Chuck Gipson

Come explore the full spectrum of cardiac care starting with the BLS level of "good" cardiac care. Measuring the effectiveness of care delivered and debriefing a call makes a difference in cardiac outcomes. Learn how to give feedback on performance so providers can deliver optimum patient cardiac care at the BLS Level, setting up the best opportunity for positive outcomes. (EMS-A or C, RN, RT)

Human Trafficking - Ray Fiedler

In this presentation we will discuss some of the myths surrounding trafficking as well as information about traffickers and their control methods. We will examine information about victims, information surrounding the prostitution/trafficking culture, and challenges encountered in working with victims. We'll also look at some lowa specific cases and experiences that some survivors have shared. (EMS-O, RN)

CPAP: From the Bedroom to the Bambulance - Jamie Temple

That difficulty breathing call at "o'dark thirty" can easily be your patient's last, especially if they are in full-blown pulmonary edema. This session explores the physiology behind CHF and pulmonary edema and the benefits that CPAP therapy can deliver to your patients. CPAP therapy is gaining momentum in the pre-hospital arena and now is your opportunity to hop on the CPAP bus! (EMS-A or C, RN, RT)

EMS & the Criminal Investigation-When EMS Arrives on the Scene First - Mark Ludwick

This session will examine the role and responsibilities of EMS on a crime scene. We will discuss what EMS needs to do to identify and preserve potential evidence as well as look at the importance of documentation by EMS providers who were at the site. Lastly, we will also consider the possible long-term effects on the EMS responders who were first to the scene. (EMS-O)

ALS Sessions:

Burns Management - Eric Hamer

In this session we will review the classification of burns and practice measuring total body surface area affected using both the rule of 9's, as well as the palmar method for pediatrics. We will then look at treatments including using the consensus formula for calculation of fluid administration for burn treatments. (EMS-T, RN)

Overcoming Challenges & Limitations in Rural Trauma Response - Dan Stein

Treating trauma in a rural setting has its own challenges. We will examine how using critical thinking in EMS care as well as all the phases of patient care is critical. We will also discuss some of the misconceptions of the "Golden Hour" and why trauma patients really die. You will better understand the golden principles of prehospital care and better able to utilize the national Field Traige Guidelines. (EMS-T, RN) **Surviving Sepsis- Chuck Gipson**

Sepsis is truly a life-threatening medical emergency. In this presentation we will take a journey into caring for a patient with sepsis from setting up a system wide approach for identifying patients with sepsis to delivery of life saving treatments. Come help demystify the mystery. (EMS-M, RN, RT)

Main Squeeze: Choosing Vasopressors - Janet Taylor

What is the best choice of vasopressor for your patient when you have more than one to choose from? Which one will cause an increase in myocardial oxygen demand? How can I help my patient without doing additional harm? This presentation will address the most common vasopressors in EMS, and which one(s) are the lesser of evils for your patient. (EMS-M or C, RN)

Documentation – Don't Give Them Any Arrows - Jamie Temple

Name one skill you use on every response...its ok, I'll wait. That's "write", it is your ability to author a quality patient care report. Remember - perception is reality. This session will focus on best practices and tips to help you pen a robust PCR, by reviewing charting blunders and offering suggestions for improvement. Remember; don't give the archers any arrows! (EMS-O)

CCP Sessions:

Ventilator Management - Taylor Buchholz

Every dial spin or button press on your ventilator can harm a patient if you do not know what you are doing. You have had ventilator training, right? But was your ventilator education either a long time ago, too brief or nothing stuck? Can you handle simple ventilator functions but get uneasy when things get complicated? Maybe a refresher in ventilator concepts is just what you need! This session will help you to feel much more confident the next time you grab that ventilator off the shelf. (EMS-A, RN, RT)

The Red Car Conundrum - 12 LEAD EKG - Jamie Temple

If local law enforcement announced a new strategy to curb speeding by ONLY looking for and pulling over red cars, would you think that was a sound strategy? EMS has basically employed the same strategy with 12 Lead EKG interpretation. We are looking for ST segment elevation so that we can call that ever-popular STEMI alert! Congratulations, you pulled over the red car. However, what if a white, black, or gray car was speeding past and nobody noticed? This session will introduce and discuss some additional items and patterns that we need to recognize. (EMS-C, RN, RT)

The Right Stuff: Critical Thinking Application (Critical Care Version) - Janet Taylor

Going through the courses and memorizing the parameters in labs and hemodynamics just aren't enough. Being able to apply this knowledge to actual cases will help reinforce your knowledge and help "work out the kinks" of critical thinking and application. In this presentation, you will see actual case studies of patients. From this, you must decide what is wrong with the patient, what the medical team did right or wrong and what YOU need to do to improve the patient's outcome. Lab results, hemodynamics, shock states and ABGs' with vent settings adjustments are reviewed. (EMS-A, C or M, RN, RT)

Hemodynamic Monitoring and Circulatory Augmentation Devices - Margaret Mitchell

You have been asked to transport a patient with an arterial line and an Impella. What do you know about these devices? What complications should you be prepared to troubleshoot? Join "Mitch" in this session as she makes sure you are comfortable with hemodynamic monitoring and circulatory augmentation devices such as LVADs, IntraAortic Balloon Pumps (IABPs), and Impellas. (EMS-C or M, RN, RT)

Pain Management in the Field – Bryon Bellinger

In this session you will learn to better assess the different types of pain a patient can have and examine pharmacologic options for their pain in a prehospital setting. We will also discuss safety and risk aspects of pain management in the field with particular emphasis on high risk populations such as children. Lastly you will learn key documentation and hand off elements related to pain management. (EMS-M, RN)

Skills and SIM Lab Sessions:

This year, instead of attending a lecture, during each of the session times a limited number of participants may choose to spend the session doing skills and scenarios. Varied speakers from the day will join Kim Hamilton, RN and simulation specialist, to facilitate the activities. Run through a high-fidelity manikin simulation, apply a junctional tourniquet or pelvic sling, initiate an external jugular IV, needle decompress a chest, or join AHA Mission: Lifeline representatives for a stroke simulation. These are some of the skills and scenarios that may be available during one or more of the sessions. A more specific list of activities each session will be provided the day of the conference. Participants may attend only one skill session. (EMS-A, C, M or T, RN)
